## Membership Levels & Benefits

### 1. **VSPF (Video Services Provider Forum) - Annual Dues: \$5,000**

This group consists of video telecommunications service providers.

#### **Benefits:**

- Eligibility for election as VSF Director or appointment as VSF Officer
- One vote in VSPF and in VSF
- Unlimited number of attendees at VSF Meeting Series meetings and right to bring guests
- Minutes of all meetings plus expanded documentation
- Right to obtain exhibit space at annual technical conference (VidTrans) at a discount
- VSF Member web page: posting of company logo and activation of link from VSF page to member company's web site
- Listing in the web-based VSF Video Services Directory
- Right to obtain exhibit space at annual technical conference (VidTrans) at a discount

### 2. **VSIF (Video Services Industry Forum) - Annual Dues: \$5,000**

This group consists of television and video telecommunications equipment manufacturers.

#### **Benefits:**

- Eligibility for election as VSF Director or appointment as VSF Officer
- One vote in VSIF and VSF
- Unlimited number of attendees at VSF Meeting Series meetings and right to bring guests
- Minutes of all meetings plus expanded documentation
- Right to obtain exhibit space at annual technical conference (VidTrans) at a discount
- VSF Member web page: posting of company logo and activation of link from VSF page to member company's web site

### 3. **VSF Associate Membership - Annual Dues: \$2,500**

#### **Benefits:**

- Can choose to join either the VSIF or VSPF as appropriate.
- Eligibility for election as VSF Director or appointment as VSF Officer
- One vote in VSF and VSIF or VSPF as appropriate
- Pay as you go to attend VSF Meeting Series meetings
- Minutes of all meetings plus expanded documentation
- Right to obtain exhibit space at annual technical conference (VidTrans) at a discount
- VSF Member web page: posting of company logo and activation of link from VSF page to member company's web site

### 4. **VSF Trial Membership - Annual Dues: \$1,000**

This level provides a one-year trial membership to enable a company to evaluate the benefits of membership.

#### **Benefits:**

- Same as VSIF Full Membership except not eligible for election as VSF Director

5. **VSUG (Video Services User Group) - Annual Dues: \$900**  
This group includes business and public sector entities that may order video services from Video Service Providers.

**Benefits:**

- Eligibility for election as VSF Director or appointment as VSF Officer
- One vote in VSUG and VSF
- Unlimited number of attendees at VSF Meeting Series meetings and right to bring guests
- Minutes of all meetings plus expanded documentation
- Right to obtain exhibit space at annual technical conference (VidTrans) at a discount
- VSF Member web page: posting of company logo and activation of link from VSF page to member company's web site

6. **VSF Consultant/Start-Up Membership - Annual Dues: \$500**  
This level includes industry consultants who run sole proprietorships and very small (start-up) companies.

**Benefits:**

- Same as VSF Trial Membership

7. **VSF Academic Member - Annual Dues: \$150**  
This level includes researchers at a university, college, or similar institution in post-secondary education.

**Benefits:**

- Same as VSF Trial Membership
